PURPOSE OF THE POSITION

The purpose of the position is to support the division with day-to-day operational issues associated with shipping movements and general maintenance. At all times the discharge of duties must be undertaken in an efficient and co-operative manner as the position plays an important role in assisting vessel arrivals and departures.

KEY DUTIES

- Provide a level of marine expertise, knowledge and operational support to effectively and safely discharge all tasks associated with shipping and maintenance operations.
- Communicate clearly and precisely with management, duty personnel, and Port Control when performing normal day to day tasks.
- Be able to provide assistance, which may arise from time to time, with port emergency responses including training as required.
- Work with stevedores, agents, customers and all port users on issues that directly affect the divisions and Corporation's operations.
- Provide assistance and services to vessels whilst in port and perform general maintenance work on an as required basis.
- Perform any range of relevant duties associated with operational requirements according to skills, qualifications and training as directed by the divisions' management team.
- Participate in agreed 24/7 roster arrangements to facilitate the safe and efficient movement of shipping within TasPorts.
- Perform other duties as required in accordance with qualifications and competence.

LEVEL OF RESPONSIBILITY / ACCOUNTABILITY

Reporting to the Superintendent Marine Operations, this position will operate under limited supervision and is responsible for managing their own fatigue, workload and priorities. This position operates within a team environment and is expected to solve problems relating to the position to ensure TasPorts operational needs are met.
