PURPOSE OF THE POSITION

The purpose of this position is to provide high quality workshop maintenance and repairs to property, plant and equipment at TasPorts King Island facilities.

KEY DUTIES

- Undertake and ensure, with the direction of the Port Operations Coordinator that all trade related repairs and maintenance requirements of appropriate infrastructure, property, plant and equipment are identified and attended to in an efficient and timely manner complying with all council, state and federal regulatory requirements as applicable;
- Undertake maintenance on wharf;
- Undertake stevedoring;
- Undertake security duties as and when required;
- Undertake basic administration as required to perform the role;
- Drive fuel trucks and transport containers as and when required;
- Comply with TasPorts health, safety and environment policies and employee safety rules; undertaking risk assessments, reporting all incidents and hazard and implementing risk controls as necessary;
- Training / supervision and workload management of apprentice; and
- Perform other duties as required in accordance with qualifications and competence.

Reporting to the Assistant Site Coordinator, this position will be subject to general supervision within the framework of defined procedures and work schedules. The incumbent must demonstrate the required skills and knowledge to perform their duties. The incumbent must demonstrate good interpersonal, stakeholder liaison and communication skills.
